Re: Request for Remote Telephonic and Virtual Public Participation at July 28, 2020 Joint Workshop

Dear Chairman Mendes and Council President Arias:

Public participation is a crucial part of our democratic process. All residents must have the opportunity to have their voices heard in local, regional and state decision-making processes, in an inclusive and transparent manner, especially in times of crisis. The scale and impact of COVID-19 is

unprecedented and it is likely the greatest and most urgent crisis you will face while in office. Now is the time to lead with courage, integrity and transparency.

The County and City workshop scheduled for July 28, 2020 will be the first time since the onset of COVID-19 that these two legislative bodies meet to discuss and coordinate emergency response. The County and City have an opportunity and responsibility to allow Fresno County residents to participate remotely and provide public comment during the meeting to inform decision making.

We respectfully request the Fresno County Board of Supervisors and Fresno City Council provide a teleconferencing option, with two-way communication options that allows either computer-users or phone-users to engage, with translation services for members of the public to participate at the July 28th joint workshop. Additionally, we request the release of past, proposed and expected COVID-19 expenditure plans at least three days before workshop to allow sufficient time for public review. Doing so will uphold the basic principles of a functioning democracy, protect vulnerable, at-risk and immunocompromised individuals from contracting COVID-19, allow you to respond appropriately to community concerns and ultimately, communicate leadership during unprecedented times. Furthermore, it will ensure compliance with Governor Newsom's [Executive Order N-25-20](#) (March 12, 2020), which grants local legislative and state bodies the authorization "to hold public meetings via teleconferencing and to make public meetings accessible telephonically or otherwise electronically to all members of the public seeking to attend and to address the local legislative or state body." The Order further states that state and local bodies should "adhere as closely as reasonably possible to the provisions of the Bagley-Keene Act and the Brown Act, and other applicable local laws regulating the conduct of public meetings, in order to maximize transparency and provide the public access to their meetings."
